Excludes replacement keys if two (2) master keys were not provided at time of vehicle lease/purchase, or if damaged keys are covered by the manufacturer's, repairer's or supplier's warranty or recall; any replacement keys made without prior authorization; any costs associated with reprogramming the vehicle's main body engine control unit; any aftermarket keys or remote devices.
